Please find attached a copy of SAHO's Collective Agreement Update.

You will note that with respect to Article 13.01 (e), effective April 1, 2017, for travel **south of the 54th parallel**, the new per kilometer Transportation Rate is **\$0.4347**.

With respect to Article 55.02 (e), for travel **north of the 54th parallel**, the new per kilometer Transportation Rate is **\$0.4908**, effective April 1, 2017.

Please ensure that SUN members working in your Local who access transportation expenses have had the appropriate adjustment made by your Employer.

Re: SUN – Article 13.01 (e) Transportation Expense

Issue:

As per Article 13.01 (e) of the SUN/SAHO collective agreement, the Saskatchewan Private Transportation Index (SPTI) has been reviewed for the period of October 2016 to January 2017 (effective April 1, 2017). This review includes Article 55.02 (e) Transportation Expense for employees who travel north of the 54th parallel.

Action Required:

Please inform all Employers and Payroll Systems of the results of the Transportation Rate review.

For travel south of the 54th parallel, the new per kilometer Transportation Rate is \$0.4347, effective April 1, 2017.

For travel north of the 54th parallel, the new per kilometer Transportation Rate is \$0.4908, effective April 1, 2017.
