CONTRACTING-IN GRIEVANCES TO ARBITRATION**

Please be advised that on July 25, 2017, SUN Provincial advanced eight grievances regarding the contracting-in of services to Arbitration. The health regions in which SUN Provincial has advanced the grievances are:

- Cypress Health Region
- Heartland Health Region
- Keewatin Yatthé Regional Health Authority
- Kelsey Trail Health Region
- Mamawetan Churchill River Regional Health Authority
- Prairie North Regional Health Authority
- Prince Albert Parkland Health Region
- Sun Country Health Region

SUN also proposed that all eight grievances be heard at the same time by a single arbitrator. On August 25, 2017, SAHO agreed to proceed with a single arbitrator as proposed by SUN.

There is no action required for SUN Locals within the above-mentioned health regions; these grievances will continue to be managed by SUN Provincial.
