**PURPOSE:** To identify internal and external activities that require a SUN representative.

**SCOPE** Board of Directors

**POLICY STATEMENT** SUN recognizes the importance of participation with coalitions, boards, working groups, committees and other partners to advance the work of the Union.

**PROCEDURE** Saskatchewan Federation of Labour (SFL) - Membership Appointments  
Biennially, SUN is requested to name representatives to SFL committees and working committees.

Expressions of interest are requested from members. The Board of Directors will determine which names will be forwarded to the SFL as recommendation for appointment to the following SFL committees:

- Indigenous
- Occupational Health & Safety
- Women's
- Young Workers
- Solidarity and Pride
- Workers of Colour



- Workers with Disabilities

Final appointment to the SFL Committees will be determined by the SFL based on recommendations from SUN.

Members appointed by SFL shall be funded. Funding may be provided by SFL or as provided for in budget.

#### SFL - Staff Appointments

SUN Staff members are appointed to the following committees:

- Central Strategy - Director of Labour Relations or designate
- Pensions & Benefits - staff designate
- Education - Organizational Development Officer or designate

#### Canadian Centre for Policy Alternatives (CCPA)- Saskatchewan Branch

As a sustaining member, SUN has a seat on the Board - SUN President.

#### Government

Requests are considered as received.

#### Saskatchewan Health Employees Pension Plan (SHEPP)

This is a joint trusted pension plan. SUN names a trustee and a partner.

- Trustee - appointed by SUN
- SHEPP Partner Committee - Executive Director

#### Saskatchewan Nurses Foundation (SNF)

The First Vice-President is appointed.

#### Saskatchewan Association for Safe Workplaces in Health (SASWH)

The Board of Directors determines representation.

#### SUN-Saskatchewan Association of Health Organizations (SAHO) Position Evaluation Committee

Two SUN members are appointed by the Board of Directors and one staff member is assigned.



Committee member attendance is funded by each respective employer.

3sHealth/Unions Benefits Committee

The First Vice-President is appointed and staff as assigned.
